- **Golf Canada Card:** \$37+HST billed in May
- **Capital Improvement Fee:** \$90+HST (Billed equally over 6 months)

Spousal Restricted Membership

About:

This is a rounds restricted golf membership for spouses at Camelot, who may want limited access to the golf course, while retaining full social privileges. Members in this classification may be 'Regular' Members if they own a membership certificate, otherwise they are classified as 'Associate' Members.

Eligibility:

This classification is available to a spouse or partner of an active Regular Member, regardless of whether they hold a membership certificate, on a continual basis. Current spouses, new spouses, social spouses or past spouses are all eligible to apply for this membership.

Privileges:

This membership classification provides the following benefits:

- 25 rounds of golf per season (One tee-time equals 1 round)
- There are no restrictions of tee times or dates
- Use of all Camelot facilities such as the practice facilities & clubhouse
- Participation in club events (count as 1 round of golf)
- This membership is not eligible for the Club Championship nor being a member of an Intersectional Team.
- Nine & Dine events, that appear on the official golf calendar, do not count as a round

Fees:

Annual Dues: \$2000 plus HST

- **Food and Beverage minimum:** \$300 (pooled with spouse or partner)
- **Hole-in-One fee:** \$2.00 per hole in one billed monthly when applicable
- **Golf Canada Card:** \$37+HST billed in May
- **Capital Improvement Fee:** \$90+HST (Billed equally over 6 months)
