



## Weekday Membership

A Weekday Membership at Camelot provides a secondary option for a *Regular* member looking for a membership who do not have a desire to regularly play on weekends and holidays. As this frees access to the tee on our busy weekend times, a dues discount is provided, otherwise this is a fully privileged Membership that offers unlimited access to both the golf course and clubhouse facilities.

Reflective of Camelot's modern approach to private Club Membership, they are available equally to ladies and gentlemen. Offering the advantages of traditional private Club Membership, *Regular Membership* at Camelot provides a non-transferable 'certificate' as one of the owners of our not-for-profit club and includes full voting rights once the entrance fee is fully paid.

This membership category is limited to 50 Regular Members. Spousal Members are eligible as well, but will NOT be included in the cap, subject to revision by the Board of Governors.

## Membership Privileges

- Unlimited access to the tee Monday to Friday, with the exception of holidays
- Weighting system for tee-time lotteries to give second priority (first priority given to fully privileged Regular members)
- Access to the course not included on weekends
- Participation in **either** the Regular or Senior Club Championship events that may occur during the restricted play periods **will be permitted**
- Notwithstanding these restrictions, twice per season Weekday Members can play without payment of applicable guest fees during guest permitted times on a weekend or holiday
- Unrestricted, complimentary use of Clubhouse
- Unrestricted, complimentary use of practice facility
- Full locker, club storage and concierge service
- Complimentary amenities including tees, pull carts, club storage and cleaning
- Reciprocal golf & guest privileges, with access restrictions as applicable at Camelot

## Entrance Fee:

To enjoy the privileges associated with Regular membership at Camelot, including the Weekday category, an initiation fee is payable of **\$15,000+HST**. Payable in 10 equal installments annually, once your initiation fee is fully paid you will be provided a 'Membership Certificate' representing your equal part ownership in the club. These installments are non-refundable, but no promissory note is required committing to the full amount should you resign before the end of the payment plan. Alternatively, to be provided the certificate immediately, you may pay the initiation fee upon application and enjoy a **20% savings** (\$12,000+HST).

## Annual Fees:

- **Annual Dues: \$4590 plus HST**
- **Food and Beverage minimum: \$1000 annually**
- **Hole-in-One fee: \$2.00 per hole in one billed monthly when applicable**
- **Golf Canada Card: \$38+HST billed in May**
- **Capital Improvement Fee: \$720+HST (Split into equal billings over 8 months)**
